Exception from frontal impact standard requirements under clause 2.1 of *Land Transport Rule: Frontal Impact 2001* and vehicle exhaust emission standard requirements under clause 2.2 of *Land Transport Rule: Vehicle Exhaust Emissions 2007*.

This form is to be used to apply for a special interest vehicle permit for a specified class MA vehicle.

Important: A maximum of 200 special interest vehicles will be granted in any one year.
A special interest vehicle must be border inspected and/or certified for entry into service in New Zealand no later than six months after the date of issue of a special interest vehicle permit.

Before you apply for a permit, you should consider the following factors:

- The matters to be considered before a permit can be granted are set out in law. This means permits are not automatically granted.
- The law does not provide for a permit to be granted on the basis of inconvenience or hardship.
- The fee is non-refundable – regardless of whether your application is granted or declined. The fee covers the cost of processing your application.
- The NZ Transport Agency is not obliged to grant a permit if it is not considered appropriate to do so.
- The Transport Agency may impose conditions to any permits issued.

Privacy

Collection of this information is required by Schedule 2 of *Land Transport Rule: Frontal Impact 2001*. All information contained in your application will be held by the NZ Transport Agency and treated as confidential subject to the Official Information Act 1982 and the Privacy Act 1993.

Under the Privacy Act 1993, you have the right to request access to and correction of any personal information you supply as a part of this application process from the Transport Agency. Fees

The indicative fee for processing an *Application for special interest vehicle permit* is \$184. This is based on the hourly rate for processing exemptions of \$184 per hour (including GST) and has to be paid before the Transport Agency starts work on the application.

There are a variety of circumstances that will affect the final fee charged by the Transport Agency. Circumstances include the complexity of the issue, uniqueness of the application or whether the investigations or analysis involved with the application has already been largely completed as part of a previous application.

The Transport Agency will advise the applicant if the fee for processing the application is going to be more than the indicative fee.

Special interest vehicle criteria

A special interest vehicle must:

- a) be owned as a collector’s item (as determined by the NZ Transport Agency); and
- b) be of historic value; or
- c) meet three of the following four criteria:

- The vehicle is and was manufactured as a two-door coupe or convertible
(evidence must be supplied with this application)
- The vehicle is and was manufactured as a high performance vehicle
(evidence must be supplied with this application)
- The vehicle’s make and model has been (or was) manufactured in annual volumes of 20,000 units or less
(evidence must be supplied with this application)
- The vehicle (or its make, model and sub-model is identified as being a collector’s item in one of the following magazines (or its respective website):
(a copy of the relevant article must be supplied with this application)
 - *Australian Classic Car*
 - *Car and Driver (US)*
 - *Automobile (US)*
 - *MOTOR (Australia)*
 - *Motor Trend (US)*
 - *New Zealand Autocar*
 - *Road and Track (US)*
 - *Top Gear (UK)*
 - *Top Gear NZ*
 - *Unique Cars (Australia)*
 - *WHEELS (Australia)*
 - *New Zealand Classic Car*

Required documentation

The following items must be included in your application. Please check to ensure each one is attached.

- Proof of title (for example, overseas registration papers in the owner's name)
- Proof the owner has another class MA, MB, MC or NA vehicle for primary use (ie registered in the owner's name, leased in the owner's name, or a company car)
- Proof that the vehicle meets required special interest vehicle criteria
- Proof of New Zealand citizenship or residency

- e) I will not sell or lease the vehicle to a third party for at least four years after the date on which the vehicle is first registered in New Zealand, and
- f) the vehicle will not be operated on the road for commercial purposes or for hire or reward, and
- g) the vehicle will not be operated in a transport service.
