FEES

- Proof of ownership for at least one year overseas (eg, airline tickets, hotel bookings, immigration visa, etc)
- Proof of New Zealand citizenship or residency, or entitlement to take up permanent residence in New Zealand

- the vehicle will not be operated in a transport service for at least one year after the date on which the vehicle is first registered in New Zealand.
