# 2-2 Vehicle attributes definitions

## 27 Fuel consumption information and vehicle efficiency and emission data

Test cycle (LANDATA codes)	Description
UNKNWN <mark>or</mark> COMPTD	Test not known for a CO <sub>2</sub> emitting vehicle. It is most likely only an estimated 3PWLTP CO <sub>2</sub> figure will be driven from Fuelsaver.
	If the Emissions Test Cycle is UNKNWM or COMPTD, stick an Estimated CO <sub>2</sub> sticker (see <b>Reference material 85)</b> to the MR2A when it is printed.

## 33 Certifier ID

This field contains the identification code of the approved vehicle inspector certifying that the vehicle complies with relevant Waka Kotahi acts, regulations and rules for entry certification. The certifier ID must only be entered when the vehicle passes entry-level certification and the Compliance Ind flag is set to Yes.





#### 36 Compliance Ind

This field indicates that entry certification requirements have been met. It does not include in-service certification requirements.

#### 37 CO2 Acct ID

This field contains the Clean Vehicles Standard Carbon Dioxide Account ID of the importer (as defined in Part 13 of the Land Transport Act 1998).

This is mandatory from 1 December 2022 for class MA, MB, MC, MD1, MD2, and NA vehicles that have a GVM of 3500kg or less when the Compliance Ind flag is set to yes. It is preferred that this field is populated using the fuel consumption statement function.

### Issuing an MR2A for approved new vehicles


There are a number of vehicle manufacturers and importers whose vehicles can be issued with an MR2A registration form without having to be certified by an entry-level vehicle inspector. It must be a complete, standard production vehicle (except bare chassis or cab/chassis units that require additional construction and have the appropriate temporary certification).

In cases where authorised manufacturers or importers are unable to access LANDATA (eg they do not have an electronic connection to LANDATA, or there is a problem with their connection), the process described below must be used to issue an MR2A to the vehicle. The manufacturer or importer must provide an **LT4085N** and a Fuel Consumption Statement and CO2 Account ID. No other documentation is required.
